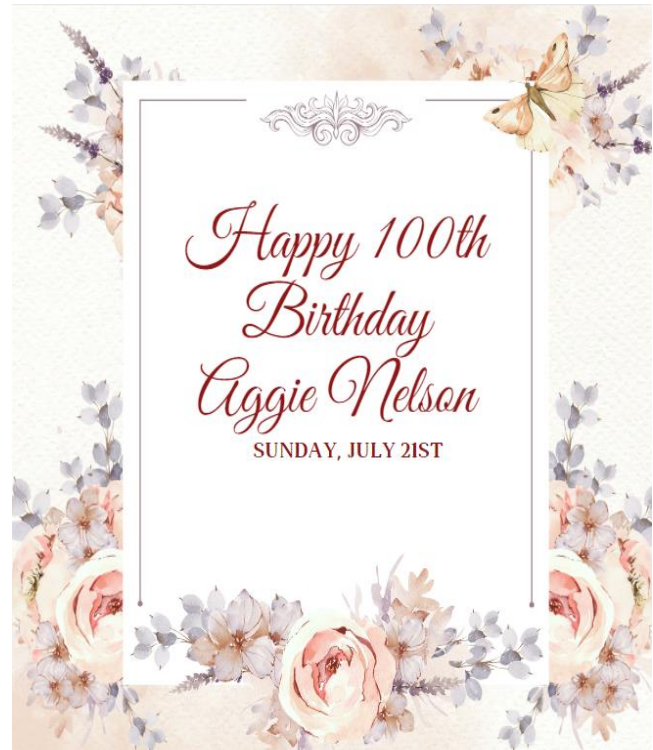

Marvel Joyce Anderson

September 24, 1935 – June 22, 2024



Marvel Joyce (Krause) Anderson was born on September 24, 1935, at the St. Cloud Hospital to Herbert Krause and Clara (Beck) Krause. She grew up on the Krause Family farm 10 miles east of Rice, MN. Marvel was baptized at St. John's Lutheran Church also known as

Dixville Church near Royalton, MN.

Marvel attended Benton County School District #38 for her elementary education. She said that the school was just a short walk down their driveway so she would try to follow her sister to school. Her parents decided to just enroll her so she was four years old when she started first grade and only 16 years old when she graduated from high school. Marvel attended Trinity Lutheran Church School in Sauk Rapids for her 7th and 8th grade year, she was also confirmed at Trinity in 1948. She then attended and graduated from Sauk Rapids High School in 1952.

Marvel attended St. Cloud Teachers College (St. Cloud State) and completed a 3-year teaching degree in 1955. In the summer of 1955, she worked as a waitress at Rutgers Pine Beach Lodge on Gull Lake. In 1955, she accepted an elementary teaching position in Willmar, MN. Marvel continued her education with summer sessions until she earned her bachelor's degree in 1957. She moved to Mound, MN, and taught there for three years.

Marvel had met Eddie through his sister, Ruth, when she was teaching in Willmar. They were married at St. John's Lutheran Church on July 8, 1961. Marvel got a job teaching in Ortonville in the fall of 1961 and taught there for two years. Marvel and Eddie lived in Clinton then moved to the Anderson family farm in 1975. Marvel loved farm life and being a mom and grandma. She had big gardens and was often found in the yard or in the field. She was a substitute teacher, a 4-H leader, a Sunday School Director, and held many positions at church. She was a member of the September Birthday Club which is the oldest organization in Clinton. She was also a charter member of the Minnesota "Marvel" Club. She loved helping out in her community and quilting at Trinity Lutheran Church was one of her favorite groups in her later years.

Marvel is survived by her children: Dean Anderson (Sharon Schroeder) of Hopkins, MN; Joleen (Matt) Rein of Center City, MN; and Lynn (Dan) Retzlaff of Fargo, ND; two grandchildren: Anna and Erin Rein; step-granddaughters: Sarah Eichhorn, and Jordan (Brandon) Derhaag; and step-great-grandchildren: Tristan, Naveah, Savannah, Sawyer, Kora, and Callen.

Marvel was preceded in death by her parents, Herbert and Clara Krause; her sister, Lavina; her brother-in-law, Hubert; and her husband, Eddie.

Larry Howard Anderson was born on July 8, 1949, in Ortonville, MN, to Russell and Edna (Rebehn) Anderson. A lifelong resident of Clinton, Larry graduated from high school in 1967 with a thirst for knowledge that led him to pursue higher education. Larry attended college at

Concordia Moorhead and at Canby Vo-Tech studying farm management and diesel repair, before proudly serving the Army National Guard for several years.

Purchasing a farm one mile from his parents in 1972, Larry farmed 400 acres and a small herd of cattle and remained living there for the next 50 years. A son, Dan, came in 1977 and then he was married to his beloved Trudy Amunrud on August 15, 1987, raising her children, Julie and Troy, as his own.

A lifelong fan of old machinery, Larry attended any farm show or threshing bee he could and kept a collection of model tractors and vintage cars on display, along with restoring several tractors of his own. He was a respected member of the Clinton American Legion and the Olde Time Machinery Club, where his presence and contributions were greatly valued. Additionally, he served on the Trinity Lutheran Church Council and dedicated his time to the St. Pauli Lutheran Church Cemetery Committee.

Preceding him in death are his wife, Trudy Anderson in 2020; and his parents.

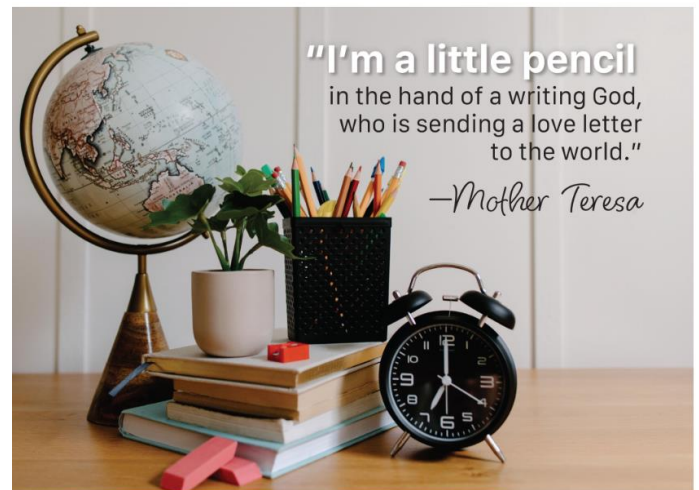

apply - (Ottertail Power & Renewable Energy rebate). We are also researching the Govt rebate and the steps it requires. A special meeting can be called to review final forms once they come.

- Call Committee - A council rep needed on the call committee. Donna volunteered with Donnette as her backup if needed.
- Donna checked with the Big Stone County Fair to see if we should do the service there on July 14 - Yes we will, Jim will be gone and contemporary crew will take over.
- The quote for Parsonage furnace for around \$12,000 was reviewed - ready if we need it and have a quote with Nelsons.

New Business:

- We received a donation request from Essentia Health Foundation - we respectfully decline giving.
- We received a thank you from Southwest Minnesota Synod - \$4000.00 Mission Support.
- We received a donation from the Bernice Mattke Memorial of \$500 to be used for Bible School/supplies/food.

- Ink Toner for the Color Printer is needed. Motion by Deb to purchase the standard yield ink was approved.
